Abstract: An indicator of the efficiency of any educational system is its connection to the immediate reality and its ability to develop skills that are considered useful for adapting to more or less predictable life contexts. SUBIECTIVITATEA – TRĂSĂTURĂ DEFINITORIE A LIMBAJULUI

Subjectivity - defining feature of the language

Abstract: The one who linguistically dealt with subjectivity, although there were other attempts before him (see DAD 2002: 552), was Émile Benveniste. Subjectivity is understood as the way in which the speaking subject makes his presence felt in his utterance or how he qualifies the utterance itself. For Benveniste, subjectivity is intrinsic to human language. Catherine Kerbrat-Orecchioni (2009: 169) defines the notion of subjectivity by dealing with the subjective/ objective opposition at textual level. Depending on the manner in which it is expressed at utterance level, Catherine Kerbrat-Orecchioni (2009: 165-168) identifies several types of subjectivity: on the one hand, deictic subjectivity, as opposed to affective or evaluative subjectivity, i.e., explicit or implicit subjectivity.

Called deixis/"ambreior"/shifter/reflective token/sui-referential expression / indicator / indexical sign (see DDAD 2015: 109), the deictic reference reflects "the connection between words and context" (Hoarţă Carăuşu 2004: 49), referring either to the identity of the interlocutors or to their situation at the time of uttering, as Oswald Ducrot states (see NDEŞL 1996: 240), and it is an indicator of subjectivity. In addition, Catherine Kerbrat-Orecchioni (2009: 40) identifies marks of subjectivity (which she calls subjectivemes, subjectivity-bearing characteristics) in several grammatical classes: nouns, adjectives, verbs, modalizing adverbs.

Narrative techniques and aspects of subversiveness in the 60th generation: Alexandru Ivasiuc

Abstract: After culture and literature pass, in the 1950s, through a period of ideologization and adherence to the command of communist politics, after 1964 there will be some relaxation of the totalitarian regime within the framework of communism. The historical circumstances forced the young authors to "discover" those forms of expression that would be tolerated by the new regime, to bring an innovative air to the art of writing, as if the uprooting of Romanian culture had brought it some benefit. Authors established in the post-war period seem to be waiting for a new breath, brought by the young generation, appearing as if from nowhere. His assertion as a novelist was abrupt and surprising in that this writer had the courage to approach subjects with a social, political and existential tone with realism and an extremely sharp critical sense. But his prose generally dealt with the subjects they could it disturbed the totalitarian political class, in other words the communist nomenclature and the repressive security apparatus.

If we observe the literature of his time, but also the content of the criticism of the time, we will observe great prudence on the part of intellectuals, because Alexandru Ivasiuc skillfully extracts from Marxist theory the radical factor as a tool to fight against stagnation, but not that perpetual radicality that could have led to nihilism; a world of negation being considered worse than a concentration camp, requiring a harmonious combination with the militant spirit in culture, with the edification of the human person and personality, giving the individual full freedom to fulfill the phenomenon of knowledge and to follow his own path in life.

The relationship between totalitarian utopian ideas and ethical principles

Abstract: This article attempts to make a link between totalitarian political utopias implemented in reality and ethical principles. At the same time, it will discuss two critical concepts at the basis of utopias, namely 'idealization' and 'ideal'. The article will attempt to answer the question "Why is there still sympathy for the communist regime today?".
